

Curtin Law students studying at 57 Murray Street may use the Library located at the Curtin Graduate School of Business (CGSB) across the road.


Essential texts, legal reference items, recommended readings, and print/copy facilities are available here. Lockers are also available for charging laptops and devices.

- Items available for loan are held at TL Robertson Library at the Bentley campus. Check the Library website at *library.curtin.edu.au* for opening hours.




REQUIRED READINGS
